GORJ"**, the procedure carried out within the project entitled **"PHOTOVOLTAIC POWER PLANT WITH INSTALLED CAPACITY OF 14.06 MW, WITH STORAGE FACILITY, IN COJANI, JUD. GORJ"**, a project to be carried out in the village of Cojani, within the city of Targu-Carbunesti, Gorj county, for the financing of which, the undersigned has submitted an offer (financing request), under the conditions stipulated by: **the National Recovery and Resilience Plan; Pillar I. The green transition; Component C6 Energy; Investment measure - Investment I.1 - New electricity production capacities from renewable sources, Supporting investments in new electricity production capacities from renewable wind and solar energy sources, with or without integrated storage facilities**, for which received the Decision regarding the acceptance for financing.

Considering the fact that, until the deadline for receiving requests for clarification, namely **03.11.2023, 16:00**, a request for clarification was received from a potential economic operator bidder, clarification that together with our answer, will be published on the company's website ([www.sergcompany.ro](http://www.sergcompany.ro)) and will be brought to the attention of all interested economic operators, at the same time, we inform you that this request for clarifications that was received, involved the need to take steps to the authorities that manage the Financing Program under which the investment project is being carried out and implicitly, the present acquisition procedure, respectively it was necessary to request a point of view from the Ministry of Economy, so as to ensure the transmission of a competent answer that is in accordance with the provisions of the governing legislation of the project's call. Also, taking into account the fact that the deadline for submitting answers to clarification requests is today, the **10<sup>th</sup> of November 2023, at 4:00 o'clock p.m.**, and until now, no answer has been received from the authorities, containing their point of view regarding our steps taken as a result of the request for clarifications received, we are in the situation of having to extend the deadline for responding to requests for clarifications and implicitly, the deadline for submitting offers, so as to ensure the necessary time for the preparation of the offer, to any potential economic operator interested in participating in this procurement procedure, carried out by our company.
